IR Claims Only: A new Economic Research Queue has been added to Trust Online for all DCPF Trusts including:

- BW
- AWI
- USG
- OC
- FB

The system activity code "ECONOMIC" will automatically be applied when the Law Firm enters information on Part 8 of the claim form **or** when an Economic Report is uploaded to the Documents tab.

The following types of claims will be placed in this new research queue after completion of the review process and prior to a release being generated:

- Claims that have the amount of last annual wages on **Part 8: Employment Information for Economic Loss** completed.
